



Making a Gift of Stock to the Campaign for Justice

Thank you for your inquiry regarding how to make a gift of stock to the Campaign for Justice. The second page of this document is a Letter of Authorization which is to be provided to your financial advisor/institution. It contains all the information needed to complete a gift of stock.

You will note that the Letter of Authorization requests that your financial advisor/institution indicate that the gift is coming from you specifically. As we regularly receive gifts of stock, providing your name on the transfer will facilitate proper matching of the funds to your gift and acknowledgement. However, if you prefer to make this gift anonymously, please direct your financial advisor/institution to advise us that a gift has been made and to also indicate the specific gift amount so that we may tie the specific dollar gift to the Campaign for Justice. Of course, you can certainly email us yourself indicating the date of transfer in lieu of asking your broker to do so or do this in addition to requesting your financial advisor/institution advise us of the gift on your behalf.
